## UPPER LIMIT

**Ebro River:** Left and right shore.

Mequinenza Dam (30T X773750 Y4584914)

**Segre River:** Left shore, La Granja d'Escarp Mines, on the border between the Province of Zaragoza and Lleida. (30T X777784 Y4587703)..

**Right Shore:** Border between the Provinces of Huesca and Zaragoza (41°24'26.86"N 0°20'08.63"E).

## LOWER LIMIT

**Ebro River:** Left shore, La Valls de Burs, except the shore of the municipality of Almatret (Lleida) (30T X783110 Y4570900).

Right shore, mouth of the Matarraña River. (30T X781758 Y4570494).

**Matarraña River:** Water intake system of Nonaspe (30T X778680 Y4569200), the entire left shore of the dammed waters.

**Length: 63 Km**

• The General Fishing Plan in force is to be applied to the rest of the species that inhabit the waters of the fishing area.

• From January 1 to December 31: from one hour before sunrise to 11 pm.

## BAITS PERMITTED

- Fishing with a rod is allowed (maximum two per fisherman), using the following natural baits: vegetables and products with a food-based origin (whether mixed or processed), insects and worms that are indigenous to the area (dead or alive), animal parts (except fish), eggs and embryos from indigenous species.
- Rod fishing with any type of artificial bait is allowed.
- The use of any exotic species as bait is prohibited (whether dead or alive; this includes parts of exotic species and/or derivatives therefrom).



- Fishing using live fish of any species as bait is prohibited.
- It is prohibited to bait or "chum" the waters - except in training and sports fishing events for which baiting is authorised in all of the sport fishing area. In this latter case, baiting of the waters may be done exclusively when fishing from the shore and only during the time spent fishing. This exception applies to fishermen who prove membership with the Aragonese Federation of Fishing and Casting. In these cases, the provisions set forth in the FEPYC (Spanish Federation of Fishing and Casting) and FAPYC



(Aragonese Federation of Fishing and Casting) competition rules and regulations will apply. In order to bait the waters, the fisherman must carry a copy of the "Sworn Statement for Baiting while Training for Freshwater/Carp Fishing Championships" on him while fishing. This is valid exclusively during the twenty days prior to a championship. Likewise, the fisherman must carry a document that attests to his registration in the championship for which he is training. As only baiting from the shore is authorised, the use of buoys for marking baiting points is not allowed.

## SPECIAL CONDITIONS

- Fishing with traps and nets of any kind is prohibited, with the exception of nets/traps for red crayfish fishing and landing nets to help in extracting the hooked fish at the shore.
- Fishing by hand and with harpoons is prohibited.
- The use of traps, nets, and other devices like such as buckets, basins, ropes, stringers, and similar materials passed through the operculum of the fish to keep the captured fish alive or dead inside the water is prohibited. The use of the necessary gear for the proper undertaking of the activity (traps, nets, or buckets in boats to

keep the fish alive) will be authorised only during championships - provided these items are duly disinfected before and after the competition.

- Bottom fishing with a buoy is prohibited.
- The fisherman must disinfect any gear and devices used while fishing in accordance with the specific guidelines that appear in the applicable disinfection protocol and in the protocol for monitoring the zebra mussel, which can be consulted at <http://www.chebro.es> and <http://www.aragon.es>. To prevent propagation, the use of boots with felt soles is prohibited.

- The minimum distance between fishermen is to be 10 metres and this distance will only be required when one of them make such a request - always upholding the concept of preference, which is granted to whoever first accesses the fishing spot. If fishing is carried out from a boat, the minimum distance is to be greater than 50 metres - except in embarkation and disembarkation areas. When carp fishing, the minimum distance between fishermen is to be 25 metres whenever the fishermen so request.

## NAVIGATION AND FISHING FROM A BOAT

- The practice of trolling is prohibited, understanding "trolling" to be the type of fishing based on dragging gear from a moving motor boat.
- Fishing from a boat is generally authorised. For safety reasons, boat fishing is not authorised in waters located less than 400 metres from the

dam. For boat fishing, a "Sworn Statement for Undertaking Navigation and Boating" must have been presented before the corresponding organisation and the necessary instructions and requirements can be found at:
